- C. Vice Mayor Drake made a motion that all committees representing the Town of Pleasant View have to come before the Board of Mayor and Aldermen. Alderman Pritchett **2nd** the motion.

After discussion and input from the City Attorney that the Resolution adopting each Board should have who has to appoint the individuals on the Board, Vice Mayor Drake **rescinded** his motion and asked for the topic to be taken to Workshop. Alderman Pritchett **rescinded** the **2nd** to the motion.

Mayor Keenan asked the City Attorney to review the Resolutions and By-laws on our current boards to see if they were set up where the Board of Mayor and Aldermen appoint the members for the Workshop.
