A. Application for Beer Permit received from:

Pleasant View Hospitality, LLC for Hampton Inn, 2606 Hwy 49E,
Pleasant View, TN 37146 – on-premise beer permit – application submitted on 11-4-19

Vice Mayor Drake **motioned** to approve the beer permit application for Pleasant View Hospitality, LLC for the Hampton Inn. Alderman Pritchett **2nd** the motion.

Vice Mayor Drake **motioned** for Question. Alderman Pritchett **2nd** the motion. **All Aye. Motion passed.**

Vote on the motion to approve the application: Vice Mayor Drake – **Aye**. Alderman Pritchett – **Aye**. Alderman Anderson – **Aye**. **Motion passed.**

B. **ORDINANCE 97-2 – VIOLATION OF ORDINANCE WHICH ESTABLISHES RULES AND REGULATIONS FOR THE SALE, STORAGE, POSSESSION AND TRANSPORTATION OF BEER WITHIN THE TOWN OF PLEASANT VIEW. THE SPECIFIC VIOLATION IS T.C.A. 57-5-301 (a)(1):** A permit holder engaging in the business regulated hereunder or any employee thereof shall not make or permit to be made any sales to minors. Neither the person engaging in such business nor persons employed by him shall be a person who has been convicted of any violation of the laws against possession, sale, manufacture and transportation of intoxicating liquor or any crime involving moral turpitude within the last ten (10) years.

The City Attorney stated she had spoken with the attorney from the Alcoholic Beverage Commission and confirmed that they had written the citation to Sidelines and that the Town

did have concurrent jurisdiction over beer violations. A \$1,500.00 fine was issued by the ABC Board which has been paid in full by Sidelines.

Sidelines Manager, Kristy Winters was in attendance and confirmed that this was the establishment's first violation and that the employee involved was fired immediately.

Alderman Anderson asked the City Attorney about the maximum fine. The maximum allowed for a responsible vendor is \$1,000.00 and there is no minimum fine.

Mayor Keenan said there is no precedence on this issue where the ABC has given a citation and a fine has been paid to them. He provided information on fines that were given to other establishments for past violations.

Kristy Winters said they have been more diligent since this incident happened and prays this will never happen again.

Alderman Anderson **motioned** to impose a \$500.00 fine or a 15 day suspension of the beer license. Vice Mayor Drake **2nd** the motion.

City Attorney Noe stated there is no provision allowed for a suspension in this instance.

Alderman Anderson amended his **motioned** to remove the 15 day suspension. Vice Mayor Drake **2nd** his amendment.

Alderman Pritchett **motioned** for Question. Mayor Keenan **2nd** the motion. **All Aye.**

Vote on the motion to approve the \$500.00 fine: Alderman Anderson – **Aye.** Vice Mayor Drake – **Aye.** Alderman Pritchett – **Aye.** Mayor Keenan – **Aye.** **Motion passed.**

ADJOURNMENT

Alderman Pritchett **motioned** to adjourn. Vice Mayor Drake **2nd** the motion. **All Aye.** **Motion passed.** Meeting adjourned at 6:03 p.m.
