ORDINANCE 20-09

AN ORDINANCE AMENDING THE TOWN OF PLEASANT VIEW MUNICIPAL CODE, TITLE 9 BUSINESS, PEDDLERS, SOLICITORS, ETC. CHAPTER 3, SECTION 9-307 MOBILE FOOD SERVICE PERMITS, SUBSECTION (B) APPLICATION.

WHEREAS, the food truck industry is a growing and vital economic generator and there is increased interest in short term food truck vending in the Town of Pleasant View; and,

WHEREAS, the Town desires to promote economic development through the encouragement of vibrant entertainment alternatives, including accommodating the popularity and growth of the food truck industry,

WHEREAS, the Town desires to promote economic development through the encouragement of vibrant entertainment alternatives, including accommodating the popularity and growth of the food truck industry.

WHEREAS, the Town strives to ensure the safety, security, sanitation, of businesses and uses within the town to protect the public.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMAN OF THE TOWN OF PLEASANT VIEW, TENNESSEE, AS FOLLOWS:

Title 9, Chapter 3, section 9-304, subsection (A) (2) is amended to read as follows:

(2) Public Property. Food Trucks may operate at times in Town parks upon approval by the Parks and Recreation Board of the Town of Pleasant View. Concessions that are a part of local youth league sports as approved as part of the contract of use of the sports complex are exempt from permit but must be located within the park complex and approved by the Parks and Recreation board. Sanctioned Special Events hosted by the Town as well as the annual Pleasant View Volunteer Fire Department Picnic and Parade event are exempt from this section.

Title 9, Chapter 3, section 9-304, subsection (A)(3) is amended to read as follows:

(3) Private property. Food Trucks may operate on private property where there is a commercial, office, educational, church, or industrial use subject to the following conditions:

Title 9, Chapter 3, section 9-304 (A) (3) (f) is amended to read as follows:

(f) Minimum Distance to Established Restaurant. No food vendor or food truck may set up within three hundred (300) feet of the front entrance of any existing Restaurant without the written permission of that establishment with the exception if it is a sanctioned special event hosted by the Town.

Title 9, Chapter 3, section 9-307, subsection (B) is amended to read as follows:

(B) Application. A mobile food service vehicle operator shall apply for a Mobile food service permit by payment of one of the following, a twenty-five(\$25)dollar one(1) day application fee, or a thirty (30) day permit application fee of fifty (\$50) dollars, or a two-hundred (\$200) dollars annual application fee, the term of the permit shall begin on the date shown on the permit. The term of a permit shall be no longer than shown on the permit application or under no circumstance over 1 year from issuance date.

1 (i) A copy of insurance coverage in the amount of \$1,000,000.00 general liability.

1 (j) A copy of any applicable and or required business license whether it be State, County or Local.

BE IT FURTHER ORDAINED, that this ordinance shall become effective immediately upon its final passage and the publication of its caption in a newspaper of general circulation within the Town of Pleasant View, the public welfare requiring it.
