SWIMMING POOL AND SPA GUIDELINES

Residential Pool

1. Fill out application
2. Submit site plan (Drawing)
3. Submit pool or spa details
4. All electrical work will require proper electrical permit and inspections
5. Requires a four foot fence with self latching gate (audible alarm system may be required)
6. Requires alarms (with audible alarm and separate from home security system) on any door leading from the house to the pool.

****Please reference Appendix G (2009 edition) of the International Residential Code for fencing, gate, latches, and door alarm specifications. Copy available on request.****

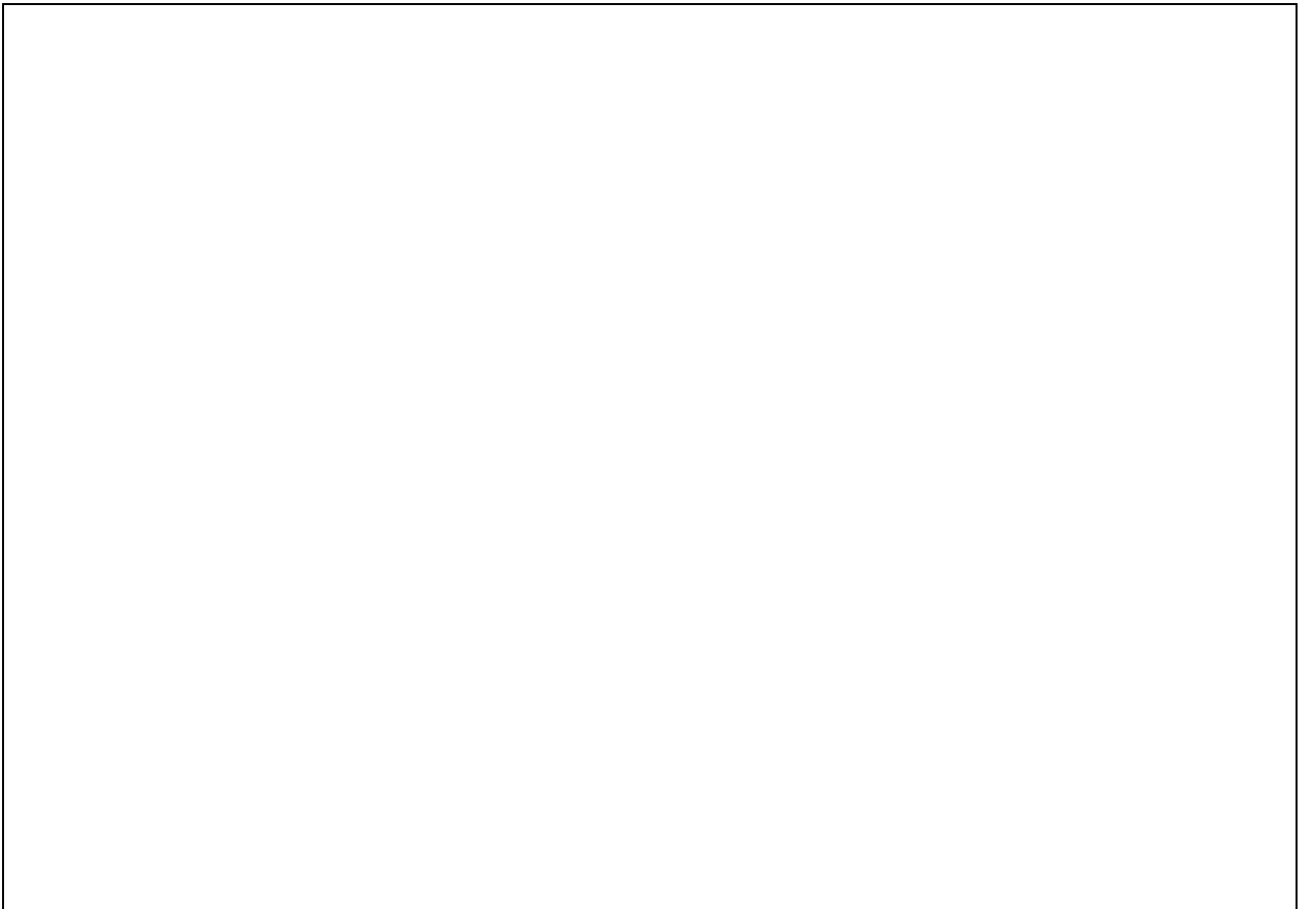

SITE PLAN

The site plan must show the following to be accepted:

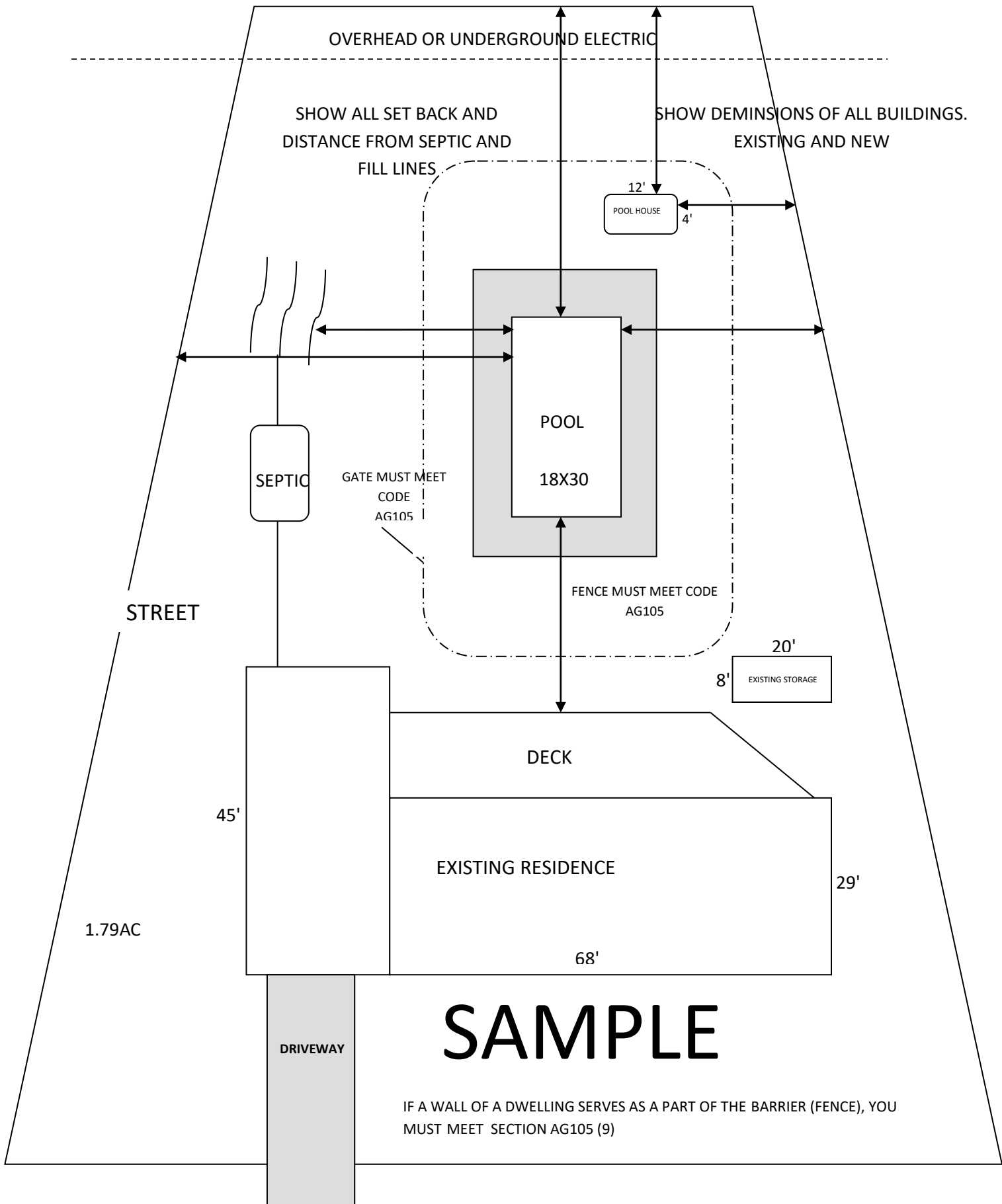
- _ Distance to and location of any critical area, such as a stream, creek, river, irrigation ditch, or floodplain.
- _ Street frontage
- _ Access/Driveway
- _ Lot lines and dimensions
- _ Location of **all** structures and specific use (any new buildings will require building permit)
- _ Location of well, septic tank, and drainfield
- _ Distances between structures and property lines
- _ Distances between pool and all property lines
- _ Location and details of all fences, gates, doors that surround the pool area
- _ Easements and/or right-of-way and any overhead or underground utility lines
